





#### Lisa Tuter

Lisa Tuter was named executive director of Folsom's Twin Lakes Food Bank in 2018. It is part of a continuum of faith and service that have been part of her life since childhood, but were jarred into perspective when she survived the blast of a bomb that killed her boss in 1995. Tuter had just left a conversation with Gilbert Murray, the president of the California Forestry Association and was about 20 feet away when he unwittingly opened a bomb sent by Unabomber Ted Kaczynski.

Tuter was 25 years old, pregnant with a bright future before her, but was suddenly thrust into an emotional bubble, thinking about her own mortality. As a woman of faith, it prompted her to ponder deeper questions about her role in her family, the community and the world. And it prompted her to change her life and career. She reckoned with God, "thank you for sparing me and my baby. Now what do you want me to do?"

Her daughter was born and Tuter became a full-time mother who participated in a Bible study that led to a volunteer role as a teaching director to 200 women. Her son was born in 1998 and she spent another seven years leading Community Bible Study. Wanting to continue to minister to others, serve her community and fulfill her calling, she joined Folsom's Lakeside Church as an adult ministry pastor in 2011. She worked on the pastoral staff at the church until taking the leadership role at Twin Lakes Food Bank.

Throughout her journey, she developed a philosophy of relational discipleship, "working on your own faith to become more like Christ, and in doing so, becoming a living reflection of him in the world," she said. It is a philosophy she employs as a defining mission of Twin Lakes Food Bank.

"Twin Lakes Food Bank was always meant to be an extension of the church," she said. "We serve those in need. Period." Our strong team of staff and volunteers are developing and implementing innovative programs and services while collaborating with constituent groups including the food bank's clients, community leaders and board of directors.

Tuter is adept at leading organizations through periods of substantial growth and transition, which came into play at the onset of the pandemic and will be tested again as the organization's building committee works to move the food bank to a larger and better-equipped facility to serve the region's growing needs. "We are bursting at the seams here," Tuter said in reference to the current operations in a modified duplex on Montrose Way in Folsom.

Twin Lakes Food Bank regularly serves almost 2,000 people, including 800 or more children, each month and Tuter said challenging times such as the pandemic "reveal the awesome generosity of our community. We couldn't be doing what we are doing without the support and donations from our community, volunteers and church partners."

During her early childhood, Harper's family relocated to Los Angeles, California, where she spent the first 27 years of her life. Having come out as a Black trans woman at an early age, Ebony began working as an activist in the trans community, emphasizing the importance of the intersectionality between her racial and transgender identity. Over the years she has transitioned from a trans activist to a human rights activist, making a difference for marginalized communities both on a local and national level.

Experience working at Project Angel Food and the Los Angeles Youth Network propelled Harper into a staff position at Children of the Night in Van Nuys, California. It was at this nonprofit, focused on rescuing children from the devastation and trauma of human trafficking and prostitution, where Harper learned community-based outreach and how to apply her lived experience as a Peer Counselor. Harper dedicated her time to helping homeless youth experiencing many of the same disadvantages and tribulations she navigated during her childhood.

Continuing her advocacy work, Harper made her way to Sacramento where she began working at the Gender Health Center as the PrEP Coordinator. Driven by her passion to dismantle systems of oppression as well as improve the quality of life for all living beings, Harper has continued her activism working at the local and national level addressing gender justice, climate justice, disability justice, and race equity.

In 2019, Harper left the California Endowment to step into her current role as the Director of California TRANScends. This statewide initiative works to promote the health and wellness of transgender people throughout the state. She's one of the recipients of the 2019 Stonewall Four Freedoms Award, the first-ever trans person to host the 2019 State Capitol Tree Lighting ceremony with Governor Gavin Newsom, and served as the 2019 Grand Marshal of Sacramento's Pride Parade.

Harper has been a speaker and facilitator at the Global Alliance for Banking on Values Summit in Vancouver, written articles for Forbes and other news sources, been highlighted on NBC and other media outlets, and serves as the newest board member for the Transgender Law Center.

### **Heather Green**

Heather Green is the Executive Director at Oasis City Center. Oasis Cares is a nonprofit program that launched on February 26, 2020 under Oasis City Center with the intentions of being a small program that supplied local students with snacks throughout the week. However, like the rest of the nation, they were forced to quickly adjust their strategies as we learned to grapple with the COVID-19 pandemic.

Immediately after closing their doors to the public on March 17, 2020, they established a drive-thru food distribution that provided staple pantry items. These items ranged from food to essential supplies like toilet paper, water and cleaning products. As executive director, Heather oversees the general functions of Oasis Cares' distributions. She works with community partners to maximize outreach efforts to provide for as many in the community as possible.

Coming into nearly a full year of shut-downs and business safety restrictions, thousands of families are now reaching out for help — some never imagined they would be in a situation where they wouldn't be able to afford these essential household items. Under the leadership of Heather, Oasis Cares has used their distribution center to provide food, resources, and hope to roughly 250,000 individuals and over 50,000 families while giving away over one million pounds of product. Over 15,000 cars have been served, sometimes waiting in over two-hour long lines to receive aid, showing the devastating effects so many are feeling from this pandemic.

The work that Heather and the Oasis City Center have done this past year represents humanity at its best. They have helped to provide essential aid and hope to their neighbors and community at large during what many would consider, the most difficult time of their life. My office and the rest of Assembly District 13 are extremely grateful for their efforts.

During the past 21 years since its founding, The Latina Center has expanded exponentially under Miriam's leadership — outgrowing two different office locations, and increasing the number of staff, volunteers, programs offered, and number of women and families they serve. Miriam is the proud purveyor of hope to more than 500 individuals who participate in the Center's parenting education courses, and an example to the students who partake in their leadership training and Young Latina Future Leaders Program in Richmond Middle and High Schools. The Latina Center also supports 100 small business and microenterprise entrepreneurs with their Richmond Economic Development program, and works to improve physical health and well-being by educating the community on HIV, breast cancer, and diabetes.

Despite humbling challenges, Miriam remains inspired by the successes of the families that The Latina Center has helped, and the more than 10,000 residents their programs have reached. She also gives credit to the foundations, individual donors, private businesses, and government agencies who have provided financial support and in-kind donations to support her organization's community-centered programs. A believer in "service above self," Miriam Wong is a passionate community leader and change maker in the Bay Area, who works daily to help her community thrive.

### Suzan W. Bateson

Suzan W. Bateson has been the Executive Director of Alameda County Community Food Bank (ACCFB) since 2001. During her two-decade tenure, the Food Bank has grown its annual budget from \$3.75M to more than \$20M; established a permanent headquarters site in Oakland; tripled its roster of employees; and more than quadrupled its annual food distribution — with a target of more than 52 million pounds this fiscal year ending June 30, 2021. The organization's success and bold approach earned it Feeding America's National Food Bank of the Year in 2016, and numerous other recognitions.

In 2020, faced with a dramatic rise in food insecurity due to the global COVID-19 pandemic, Suzan led her organization to expand services in the 16<sup>th</sup> Assembly District. Leveraging established community partnerships, Suzan led ACCFB to establish a drive-thru distribution site at the County Fairgrounds in June 2020. To date, the site has served 105,295 clients from 27,880 households. Under Suzan's tenure, ACCFB has expanded its reach and scope of food distribution into the Tri-Valley area, partly due to the Policy & Partnerships Department's deep engagement with the Tri-Valley Anti-Poverty Collaborative, a cross-sector collaboration formed to address issues of hidden poverty in the Tri-Valley Area.

In 2020, Suzan received Feeding America's prestigious John van Hengel Fellowship, awarded to one food bank leader annually in recognition of their local impact, national influence, commitment, and entrepreneurial spirit in hunger relief. Suzan is also a 2017 inductee into the Alameda County Women's Hall of Fame, which honors local outstanding women for their contributions to the community. She is currently chair of Feeding America's Western Region and serves on the Feeding America Ending Hunger advisory committee. Suzan has formerly served as both board chair and board member of the California Association of Food Banks and was formerly a member of Feeding America's Policy Engagement and Advocacy Committee.

Suzan attended California College of the Arts and was a participant in the Executive Program for Nonprofit Leaders at Stanford University's Graduate School of Business. She lives in Moraga with her husband, John and their dog, Coda. In her spare time, she enjoys celebrating just about anything she (and they) can think of with her grown children and grandsons, who all live locally.

These prevention and mitigation efforts have proven successful, as the Chinatown community remains one of the areas with very low infection rates, despite being one of the most densely populated areas in the nation. ## Alicia Garza

Alicia Garza believes that Black communities deserve what all communities deserve — to be powerful in every aspect of their lives. An innovator, strategist, and organizer, she co-founded the Black Lives Matter Global Network, an international organizing project dedicated to ending state violence and oppression against Black people.

Garza also founded the Black Futures Lab, an organization that invites Black people to experiment with new ways to build independent, progressive Black political power. In 2018, the Black Futures Lab launched the Black Census Project, the largest survey of Black communities in over 150 years, whose results focus on the economic and criminal justice concerns of Black communities in the U.S. — including special focus on LBG+ voices — and how gender shapes the lived experience of Black people in the U.S.

Garza also serves as Strategy & Partnerships Director and Special Projects Director for the National Domestic Workers Alliance, the nation's premier voice for millions of domestic workers in the U.S., where she works to build a movement at the intersections of race, gender, and the economy.

Garza is also the co-founder of Supermajority, a membership-based home for women's activism that affirms and builds women's power, training and mobilizing a community of all ages, races, and backgrounds to become the most effective advocates they can be and build a more equitable future for all women.

Garza has served in various social-justice leadership positions throughout her career. In 2009, she served as executive director for People Organized to Win Employment Rights (POWER) for the San Francisco Bay Area. In 2011, she was elected board chair for Right to the City Alliance (RTTC) in Oakland, which fought gentrification and police brutality. She has also served as a board member of Forward Together's Oakland branch, Black Organizing for Leadership and Dignity, and Oakland's School of Unity and Liberation (SOUL).

Garza has been the recipient of numerous awards for her organizing work. In 2020, she was honored on *TIME's* 100 Most Influential People in the World list and 100 Women of the Year list, and appeared on *Fortune's* "40 under 40" in the "Government and Politics" category.

She shares her thoughts on women transforming power in her monthly column for *Marie Claire*, and hosts a weekly political commentary podcast, "Lady Don't Take No." Her writings have been published by *Time*, *Elle*, *Essence*, *The Nation*, and *Rolling Stone*, among others.

Born in Los Angeles, California, Garza holds a B.A. in Anthropology and Sociology from the University of California, San Diego, and earned her Master's Degree in Ethnic Studies from San Francisco State University. She currently lives and works in Oakland, California.

## Diane Havlir, MD

Diane Havlir, MD, is a Professor of Medicine at the University of California, San Francisco. The goal of her research is to develop therapeutic and prevention strategies to respond to global infectious disease pandemics such as HIV, TB, and COVID-19. This includes the application of antiretroviral therapy to eliminate HIV and TB.

A leader in the field of HIV/AIDS research, Dr. Havlir continues to design and test strategies to accelerate the end of the AIDS epidemic by testing innovative prevention and treatment strategies that reach the persons being left behind with current approaches. In the SEARCH study, her team showed a multi-disease, patient-centered approach to HIV testing and treatment reduced HIV incidence, HIV-associated tuberculosis and HIV associated mortality, and improved population level control of hypertension in a NIH-funded 320,000 person cluster randomized study in rural east Africa.

Her research team is also working on addressing COVID-19 in San Francisco. She lead UCSF's efforts to collaborate with the Latino Task Force, CZ Biohub and the San Francisco Department of Public Health to set up low-barrier mass testing and vaccination sites in San Francisco's Mission District, to understand and intervene on COVID-19 transmission in the disproportionately-affected Latinx population of the neighborhood.

Dr. Havlir earned her B.A. from St. Olaf College and M.D. from Duke University Medical School. She performed her residency in internal medicine at UCSF and a fellowship in infectious diseases at Case Western Reserve University. Her honors include the Duke Distinguished Alumni Award, the UCSF Chancellor's Award for the Advancement of Women, the St. Olaf College Alumni Achievement Award, the HIV Research Achievement Award of the Infectious Diseases Society of America and HIV Medicine Association, induction into the Vanity Fair Hall of Fame as a "pioneering leader in the fight against AIDS," and election as a member of the National Academy of Medicine. She served as the United States Co-Chair for the XIX International AIDS Conference in Washington, D.C. and Scientific Chair for the XVIII International AIDS Conference in Vienna.

She brings business savvy and political acumen to all she undertakes, demonstrated the past year in response to the pandemic. Ms. Foust's recent accomplishments are numerous, but most importantly, she engaged with countless organizations, public and private, to advocate for the needs of nonprofits and small businesses and to channel resources in an expeditious manner. Through her leadership, the San Mateo County Strong Fund was established, creating one of the most quick and efficient compilation of resources and dispersal of funds, both public and private, in a streamlined process and kept organizations alive. After obtaining her Agricultural Business Degree from Fresno State in 1998, Lorna went on to get her teaching credential. Following a career in the classroom, Lorna returned to the agricultural field to work full time on the family farm in 2005.

Schultz Ranch, Inc. is based in Burrel, an unincorporated community in southern Fresno County where Lorna's family has farmed since 1886. They currently grow pistachios, wine grapes and almonds. Lorna manages accounting, legal, chemical tracking, and safety procedures on the ranch. On top of the day-to-day operations on the farm, Lorna is active in many community organizations including California Women for Agriculture and Central Valley Women for Agriculture, My Job Depends on Ag, the Ag One Foundation at Fresno State, Riverdale Community Foundation, Fresno County Farm Bureau, Horizon Pistachios Company, and American Pistachio Growers.

Lorna's advocacy work extends beyond farming. After a tragic accident on Highway 41 in Fresno County in November 2020 took the life of a family member, Lorna started what has become a powerful grassroots effort demanding the completion of the dangerous state highway. She created the "Widen Highway 41" Facebook page, which now has nearly 6,000 members. It has become a place for the families of victims to remember their loved ones, as well as a warning for other drivers. Her dedication to this issue created a great deal of momentum, led to the installation of community funded signage, and revived the interest of local elected officials to complete the project.

#### **Gail Pellerin**

Global pandemic, economic fallout, racial injustice, protests, devastating fires, insurrection. Despite the dark topics that dominated this past year's headlines, 2020 also recorded some positive milestones. The year marked the 100th anniversary of the passage of the 19th Amendment, guaranteeing and protecting women's constitutional right to vote. 2020 also saw a presidential election that set the highest voter turnout record in 120 years. On these two high notes, Gail Pellerin, the woman who has overseen Santa Cruz County elections for the past 27 years, hung up her hat (one of many) as Santa Cruz County Elections Clerk and passed the torch of democracy on to another. As she charts a new course for herself, she does so with the title of 29th Assembly District Woman of the Year, an honor I am proud to bestow upon this extraordinary individual.

Gail has turned Thomas Paine's quote, "lead, follow, or get out of the way," into actionable rules of engagement that guide her approach to getting things done. When, for example, she was discouraged from pursuing higher education, her drive and determination propelled her forward as she paid her own way through college, eventually obtaining a degree from Cal Poly San Luis Obispo. While cutting her professional teeth as a journalist, Gail found herself irresistibly pulled to the halls of our State Capitol and to a career in policy and politics. Taking a legislative staff position with Assemblymember Rusty Areias, Gail's knack for getting things done attracted the attention of then-Speaker Willie Brown. She was subsequently hired by the Speaker, whom she credits for providing her with in-depth knowledge of the inner workings of governmental decision-making.

Several years later, Gail embarked on a new adventure by relocating to Santa Cruz with her husband Tom Chaffin. Her prior experience with elections and campaigns led her in 1993 to accept a position as elections manager for Santa Cruz County Clerk Richard Bedal. Upon Mr. Bedel's retirement in 2004, Gail was appointed county clerk. She was later elected, and then reelected a total of four times, each time running unopposed. Her skills and knowledge were revered by her colleagues across the state, and led to her accepting the role of president of the California Association of Clerks and Election Officials, and membership in both the Voting Accessibility Advisory Committee and the Future of California Elections. Gail's reputation as an expert in election processes also landed her the prestigious position of international elections observer, where she bore witness to the birth of democracy in the Transcaucasia region.

Gail and Tom were soon blessed with two wonderful children, Emily and Jacob. Despite Gail's demanding schedule and Tom's busy law practice, the couple found the time to be fully present in Emily and Jacob's lives. After the unexpected passing of Tom in 2018, Gail channeled her grief into advocacy, actively working to increase suicide prevention and mental-health awareness.

Although recently retired from Santa Cruz County as "the head of democracy and love," – the latter being a reference to the fact that she also issued marriage licenses – the incomparable Gail Pellerin is still getting things done, and will continue to do so well into the future.

The success of this program was recognized nationally by the Ford Foundation. She was president of the San Benito County Board of Education from 1975-77, and served as Gavilan College's Dean of Liberal Arts and Sciences before retiring in 1985.

In 1989, Kathy married Anthony "Tony" Ruiz, a Spanish teacher at Gavilan College. Together, they were active in local politics. Tony was the first Mexican-American elected to public office in Hollister. Kathy served on the Democratic Party Central Committee in San Benito County. She volunteered on many local campaigns, including Leon Panetta's campaigns for U.S. Congress and Anna Caballero's campaign for State Assembly. Her deep community ties made her a valuable addition to these campaigns.

Throughout her life, Kathy has continued working to uplift the most vulnerable members of our community. She served for ten years as a court appointed special advocate for three children from Monterey County. She also served as head of the Fishes and Loaves/Peace and Justice Ministry at Sacred Heart/St. Benedict Church in Hollister. Seeing a growing need for homeless services, Kathy chaired the homeless task force that set up the first emergency shelter in San Benito County.

Across Assembly District 30, people will attest to the ways Kathy Ruiz has changed their lives for the better. Through her professional career and volunteer activities, she has spent over fifty years working to create opportunities for those most in need. #### Dr. Kathleen Rindahl

Dr. Kathleen Rindahl, an Assistant Professor at Fresno State, has been a stalwart and tireless leader in bringing health services to the rural and disadvantaged communities of Fresno County. Her commitment has never been more appreciated than during the COVID-19 crisis.

She leads teams of Fresno State nursing students who participate in the mobile health unit and in outreach clinics. They provide screenings and services, getting first-hand experience. At the same time, they attend to people who have little or no access to health care.

Rindahl, in fact, initiated the establishment of the mobile health unit. That program, working with other partners, this year has helped administer hundreds of free COVID-19 vaccinations to the elderly and to agriculture workers.

Rindahl previously led the Fresno State School of Nursing's successful application for a nearly \$149,000 Song-Brown grant to fund the "Spirit of Health" clinic that was located at the Spirit of Woman shelter in Fresno. The clinic, which now is closed, provided free health care services to women recovering from substance abuse issues and to their children.

Her efforts have been recognized by her peers. She was honored with a Nurse of the Year – Education award by the Nursing Leadership Coalition.

Rindahl, who earned a doctorate degree in nursing practice, joined the Fresno State School of Nursing faculty in 2013. Before that, she served as a migrant health nurse for the Fresno County Office of Education for 10 years.

Rindahl also has worked professionally throughout her career for different hospitals and medical groups in California.

A native of Los Angeles, Rindahl also serviced as a hospital corpsman for the United States Navy and was stationed at different naval bases, mostly on the East Coast.

Rindahl lives with her husband of 31 years, Marty Rindahl, in Fresno. They have three daughters.

### **Thao Carey**



While completing her Master's degree in Education from the University of Southern California, Liz began to entertain the idea of someday starting a school. A once proud California public education system was now in deep decline and Liz thought that there must be a better way. Liz happened to meet a terrific woman at USC who had a son with special needs. When she realized the public schools could not help her son adequately, she started a school to address his challenges. Her story inspired Liz and the idea continued to grow.

#### Fran Robertson

In response to the Covid-19 pandemic, Fran Robertson, Executive Director of Sowing Seeds for Life expanded its capacity to serve people and families in need and assembled a team of volunteers who served over 200k people in 2020-more than double their pre-Covid monthly average of about 9,000 people. Sowing Seeds for Life was able to grow their capacity to serve through their faithful corps of volunteers who transitioned to a contactless drive thru food pantry and a partnership with the Fairplex.

When Fran sees a need and food insecurity in the community, she develops a plan and executes it to provide solutions that improves lives. Over the years, she has initiated additional food programs that benefit seniors and Veterans. In fact, when it became known that more and more college students were struggling with home and food insecurity, Sowing Seeds for Life established one of the first mobile food pantries in the San Gabriel Valley emphasizing service to college students who attended Cal Poly Pomona. This effective food program is now being modeled at Mt. Sac because unfortunately food insecurity for college students persists at an alarming degree.

Fran Robertson is a graduate of Cal State San Bernardino with a degree in Marketing. She has dedicated her adult life to the efforts of non-profit organizations here in the Inland Empire and San Gabriel Valley. Her career began running the thrift shop for the Humane Society of San Bernardino. She continued with work at the local branches of the Salvation Army, The United Way, The Pomona Valley Workshop, and the Inland Empire Hope Partners (formerly The Council of Churches).

### Patricia L. Cummings, PhD, MPH

Dr. Patricia Cummings is the Director of Epidemiology Research and Evaluation at Eisenhower Medical Center in Rancho Mirage, CA. She received her doctorate in Epidemiology from the University of California Los Angeles (UCLA) Jonathan & Karin Fielding School of Public Health, and a Master's Degree in Public Health with a specialization in Epidemiology and Biostatistics from the Keck School of Medicine at the University of Southern California. With her extensive list of publications on chronic and infectious diseases, she has substantive experience working on public health issues both nationally and locally.

Dr. Cummings joined Eisenhower in 2016 to conduct epidemiologic research and perform a wide range of investigative and analytical activities related to hospital-based disease surveillance, antibiotic stewardship, infection prevention and control, health disparities, and population health. She has been the principal or co-principal investigator of multiple federal and local-funded research studies focusing on antibiotic resistance prevention, the built environment, foodborne diseases, obesity, diabetes, and cardiovascular health, including school-based nutrition and food policy implementation.

For the past year she has worked tirelessly on COVID-19 emergency response, including generating predictive models for the Coachella Valley community, tracking COVID-19 surveillance trends, and applying her expertise in pandemic preparedness to assist the hospital in its response. Early in the pandemic, she assisted community decision makers by predicting the extent of outbreak for the Coachella Valley, in collaboration with Congressman Raul Ruiz's office.

Prior to COVID-19, she led Eisenhower Health to be named the first hospital in the United States by the Centers for Disease Control and Prevention (CDC) as a *Million Hearts® Hospital* — a designation awarded to hospitals excelling in their efforts to prevent heart attacks and strokes. In 2019, Dr. Cummings also won the Silvia Moss Brown Award for demonstrating excellence in the improvement of patient care outcomes as part of her research on reducing antibiotic-inappropriate prescribing in community urgent care centers.

Before coming to Eisenhower, in 2015, Dr. Cummings developed and led the Built Environment & Health Impact Assessment Unit at Harris County Public Health in Houston, Texas. It was the first unit of its kind in Texas, and she was subsequently selected by the CDC and the National Association of County and City Health Officials to be a mentor to other health departments across the U.S. to implement similar models as part of their Health Impact Assessment Demonstration Sites.

From 2008 to 2014, Dr. Cummings worked for the Los Angeles County Department of Public Health and was involved in a number of high-profile, public health policy evaluation efforts, such as menu-labeling, the County of Los Angeles' Healthy Food Procurement Board Motion and 100% Healthy Vending Machine Policy. In 2009, she received an award from the City of Los Angeles for her research on age-related diseases, and in 2014 was invited to speak at the prestigious CDC Public Health Grand Rounds in Atlanta, GA on "Preventing A Million Heart Attacks and Strokes."



Lisa Kodimer is the Co-founder and Executive Director of Connecting a Caring Community (CCC), a non-profit organization dedicated to inspiring and mobilizing the community to live a life of giving. CCC grew out of Lisa's long history of changing people's lives by seeing a need in a community and taking action to fill it. Lisa will often say that she is not sure, if she finds the need or if the need finds her.

After almost 20 years of owning a successful gift boutique, Lisa closed shop and began living her real purpose...GIVING BACK! She took what she learned as a businesswoman, trust, loyalty, determination and the ability to connect with others, and applied it to the world of philanthropy.

Lisa was inspired in 2011 by the leader of an educational and spiritual program while visiting Israel. "Inspire a woman, you inspire a family; inspire enough families, you can change a community; inspire enough communities, you can change the world." Connecting a Caring Community started with their first program "Connecting with Moms." It began with 10 moms meeting to learn about philanthropy and filling the needs in their community. Today CCC empowers hundreds of participants and provides opportunities for giving back. Additional CCC programs include two teen groups where participants develop leadership skills and gain confidence while doing good for others, as well as a program where young adults with special needs socialize with other teens. All participants have a common goal to give, love and grow.

Lisa has taken Connecting a Caring Community from a small idea to an organization that has touched thousands of people throughout Southern California. Her dedication has inspired people to initiate new programs within their communities and create their own volunteer opportunities. Lisa's mentoring, infectious energy and passion for giving changes lives. The ripple effect of Lisa's actions is contagious and so many are learning to be givers.

CCC's programs were designed to meet in person at various non-profit organizations throughout Los Angeles County. When the pandemic hit, CCC quickly transitioned all programs to a virtual format. The organization began focusing on a response to the COVID-19 crisis by supporting the morale of front-line hospital workers in Los Angeles, assisting low-income schools and communities with remote learning resources, bringing connection to drug and alcohol recovery center residents, providing food baskets to homeless families in transitional housing, and bringing holiday cheer to hospitalized children fighting life threatening illnesses.

Lisa's passion for giving back began long before she and Brandt Blanken founded Connecting a Caring Community. In 2012, Lisa and her son developed Westhills Champions, a special needs baseball program in West Hills. For 7 years, Champions Baseball engaged over 75 special needs children and inspired over 200 teen volunteers.

Most notably, Lisa went to Las Vegas to honor the 58 people killed at the 2017 music festival by doing a good deed for each victim. Her actions inspired many others who reached out to her and sponsored even more good deeds on their behalf.

Lisa was raised in Woodland Hills and has lived in the area most of her life. She married Kory, the boy next door, who she has known since she was 2 years old. They have two beautiful sons, Kole and Kamden, who were raised with the values of giving. Lisa graduated from Cal State Northridge with a degree in Child Development and an emphasis on Special Education.

### Dr. Yen Ang

Dr. Yen Ang is the SNAP-Ed program Assistant Director at the San Bernardino County Department of Public Health, where she oversees the largest food assistant education program. She also serves as the Chair of the Department's Anti-Hunger Coalition and Health Equity Committee.

Dr. Ang is the recipient of two NACO (National Association of Counties) achievement awards in recognition of her innovations in public health. In 2019, she led the collaborative effort in getting the first and only city in San Bernardino County to adopt the SB 1192 Healthy-by-Default Kids Meal ordinance ahead of California State law. She also founded the Food Rescue Anti-Hunger Coalition in 2020, which engineers high-level collaborative efforts to reduce hunger and health inequities among vulnerable populations.

Dr. Ang earned her doctoral degree in public health with an emphasis in preventive care from Loma Linda University. She also has two master's degrees—an MSc in exercise science and an MPH in nutrition—and is a Registered Dietitian. Yen's interests lie in the management and prevention of chronic diseases through lifestyle intervention, specifically with obesity, diabetes, and heart disease.

Over the past two decades, Yen has created and achieved a number of highly successful lifestyle intervention programs in both community and clinical settings, helping hundreds of people lose weight, prevent lifestyle-related diseases, and reduce medication reliance. With her strong training in both public health and patient care, Yen was instrumental in making the Penang Adventist Hospital the first and only hospital in Malaysia a Health Promoting Hospital, meeting all 152 indicators set by World Health Organization. Under her belt is also more than a decade of experience in academia teaching undergraduate and graduate courses at universities and colleges in America and Singapore.

Yen's time in the classroom and clinical experience in the real world have helped her design and implement applied research projects that incorporate the rigors of scientific research as well as the challenges of everyday life. In the past 10 years, Yen has authored and published more than 20 scientific abstracts. She has also presented more than 50 professional presentations at international conferences, business corporations, and medical care institutions that have featured her highly innovative work in wellness and preventive care.

#### Rose Matsui Ochi

ASSEMBLYMEMBER, FORTY-NINTH DISTRICT

Rose Takayo Ochi, an attorney, civil rights activist, political strategist and recognized icon in the Asian Pacific Islander (API) community passed away on December 13, 2020 at the age of 81. She shattered numerous glass ceilings becoming the first API woman pointed to numerous national and local positions. This includes President's Carter's Commission on Immigration and Refugee Policy, the Associate Director of the President Clinton's National Drug Control Policy, Assistant US Attorney General functioning as the Director Justice Community Relations Service, Los Angeles Police Commissioner, and the first Director of the California Forensic Science Institute.

Ms. Ochi was born on December 15, 1938 in the Boyle Heights community of Los Angeles. At a young age, she faced severe racial and sexual discrimination. During World War II, when President Franklin Roosevelt signed Executive Order 9066 which authorized the forced removal and incarceration of Japanese Americans living in the West Coast, she was incarcerated for 4 years at Rohwer War Relocation Authority Camp. During this period, 120,000 Japanese Americans were sent to "relocation" camps.

Once released from Rohwer, Ms. Ochi returned to Boyle Heights and attended Roosevelt high school and UCLA. Following graduation, she initially became a secondary school teacher. When she witnessed the civil rights efforts in the early 60's, she decided to go to law school to put herself in a position to make a greater impact on the underserved. She attended Loyola Law School and upon graduation in 1972, she accepted a Reginald Heber Fellowship at the University of Southern California Western Center on Law and Poverty where she was co-counsel on a landmark education reform case, Serrano vs Priest. This case profoundly changed funding for schools in improvised areas throughout the United States.

The Serrano vs Priest case convinced her to pursue a career in public policy and advocacy. She joined Los Angeles Mayor Tom Bradley's administration where she became the Director of the City's Criminal Justice Office. In 1973, Ms. Ochi developed the Use of Force Policy after the Eula Love case and advised Mayor Bradley on the Blake consent decree, which resulted increasing the hiring of women and officers of color in Los Angeles Police Department.

On a national level, Ms. Ochi was instrumental in declaring Manzanar Internment Camp as a National Historic Site. She also supported the Redress Bill and was mentioned by President Ronald Reagan in his speech just before he signed the Civil Liberties Act of 1988. President Bill Clinton appointed Rose to the White House Office of National Drug Control Policy and subsequently, appointed her to the position of Assistant US Attorney where she was the Director of Community Relations Service. She was the first API woman appointed to Assistant US attorney.

Ms. Ochi returned to Los Angeles, and Mayor James Hahn appointed Ms. Ochi to the Los Angeles Police Commission. Again, she was the first API woman appointed to the Police Commission. Following this assignment, Ms. Ochi became the first Executive Director of the California Forensic Science Institute located at Cal State University Los Angeles. Ms. Ochi retired in 2013 and lived in Monterey Park.

# **Betty White**

For many people, Betty White might be known best as The Golden Girls' sweet and naive, Rose Nylund, (for which she won an Outstanding Lead Actress Emmy); or as The Mary Tyler Moore Show's saucy, happy home maker, Sue Ann Nivens, (for which she won two Emmy awards as Best Supporting Actress), but throughout the years Betty has proven she is as versatile as she is lovable. A television pioneer, she was one of the first women to hold positions both in front of and behind the camera, and is recognized as the first woman to produce a sitcom, Life with Elizabeth, which brought Betty her first Emmy win in 1952 and also led to her receiving the honorary title Mayor of Hollywood in 1955.

Throughout the next several decades, Betty's career clipped along at a steady pace. White was a regular on Mama's Family as sister Ellen, a role she created on The Carol Burnett Show. She also hosted the game show, Just Men, and received another Emmy for Best Daytime Game Show, the first female game show host to ever receive this honor. Nominated seven times for Best Actress in a Comedy Series for her role as Rose Nylund in The Golden Girls, White won the Emmy for its first season in 1985.

In 2010 Betty joined the cast of TV Land's Hot In Cleveland at the tender age of 88, where she was nominated for an Emmy in 2011. When she hosted NBC's Saturday Night Live in 2010, it was one of the highest-rated episodes in the show's history, and earned her an Emmy Award for Guest Actress in a Comedy Series, bringing White's Emmy total to seven awards.

White is an accomplished author, too. Two of her eight books include "If You Ask Me (And of Course You Won't)," which earned Betty a Grammy Award for Best Spoken Word Album, and "Betty & Friends: My Life at the Zoo," a love letter to the people behind the zoos who work tirelessly for the animals.

A dedicated supporter of animal health and wellness, White is a trustee of the Greater Los Angeles Zoo Association and serves as President Emeritus of Morris Animal Foundation, where she has been a trustee since 1971. In 2006, she was honored by the City of Los Angeles at the Los Angeles Zoo as "Ambassador to the Animals." She was proclaimed an honorary forest ranger by the U.S. Forest Service in 2010 and made an honorary zookeeper by the keepers of the Los Angeles Zoo, two occupations she considered as a child and before becoming an actress.

Combining the things she loves most: animals, friends and entertainment, her most passionate project came years earlier after she and her beloved husband, Allen Ludden, created their own production company and launched the syndicated series The Pet Set. Premiering in 1971 and Executive Produced by Allen, The Pet Set featured Betty welcoming celebrity friends with their dogs, cats, birds and horses — in addition to a wide range of wild animals — both in the studio and on location.

White's awards are numerous, and in addition to multiple Emmys including a Lifetime Achievement Award in Daytime, her accolades include the Career Achievement Award in 2009 from the Television Critics Association and the Screen Actors Guild Life Achievement Award in 2010. She was added to the Guinness World Records under the title, "Longest TV Career for an Entertainer (Female) and has also been named the world's "Most Trusted Celebrity" by Reuters.

# Sandra Figueroa-Villa

Sandra Figueroa-Villa was born and raised in South Los Angeles and attended local public schools. She began her community activism at Huntington Park High School and graduated from Roosevelt High School in Boyle Heights. She continued her activism as a student at California State University, Los Angeles.

Figueroa-Villa has over 47 years of experience working in the non-profit sector. She was appointed as the Executive Director of El Centro del Pueblo in 1980. At that time it only had 2 part time staff and an operating deficit of \$25,000. Today the organization has an \$8 million dollar annual operating budget to service children, youth, and families in Los Angeles with the support of over 130 professional and paraprofessional employees.

In 2003, Figueroa-Villa led the agency in a \$4.5 million dollar capital campaign to purchase and renovate a 30,000 sq. ft. facility that includes an outdoor playground to complement an indoor youth center that offers recreation to the families that El Centro del Pueblo serves. In 2005, the organization also purchased an 8,000 sq. ft. building to house the Echo Park Family Source Center and the Gang Reduction and Youth Development Program.

Figueroa-Villa has been appointed to a number of boards and commissions including the Children, Youth and Family Commission for the City of LA, the Redistricting Commission and Superintendent Search Committee for LAUSD, and has provided capacity building training to other nonprofits and volunteers on community advocacy campaigns.

Figueroa-Villa was appointed to the Board of Police Commissioners by Mayor Eric Garcetti in August of 2013. Sandra Figueroa-Villa is married to Jesus Villa, a retired educator. Her daughter Xochitl Villa attended Cal Poly San Luis Obispo and received her Bachelor's Degree in Political Science.

# **Trinity Tran**

Trinity Tran is the co-founder and lead organizer of California Public Banking Alliance, Public Bank LA, and Divest LA. She is the volunteer Executive Director of Urban Partners Los Angeles (UPLA), overseeing one of the largest walk-up food banks in Southern California. Since the start of the COVID-19 pandemic, the UPLA food bank have distributed over 126,000 grocery boxes to individuals and families in need. Trinity is devoted to helping underserved populations and transforming the financial system to advance social and economic justice.

In February 2017, Trinity created Divest LA which successfully mobilized activists behind the campaign to move the City of Los Angeles' public funds from Wells Fargo. In June 2017, she cofounded Public Bank LA, which led the Measure B ballot initiative to create a city-owned bank in Los Angeles. In June 2018, she became a founding member of the California Public Banking Alliance (CPBA) and lead organizer for the statewide coalition of grassroots groups which conceived of and sponsored State Legislative bill AB 857 to create local public banks in California. The 'Public Banking Act' was signed into law by Governor Gavin Newsom in October 2019. In 2021, Trinity is simultaneously working with LA City Council to establish the Los Angeles public bank and on state legislation to create the California State Public Bank.

#### **Rabbi Sharon Brous**

Rabbi Sharon Brous is a leading voice in reanimating religious life in America, working to develop a spiritual roadmap for a soulful, justice-driven, multi-faith ethos in Los Angeles and around the country.

Brous is the senior and founding rabbi of IKAR, a Jewish community that launched in 2004 to reinvigorate Jewish practice and inspire people of faith to reclaim a moral and prophetic voice. IKAR quickly became one of the most influential Jewish congregations in the country, and is credited with sparking a rethinking of religious life in a time of unprecedented disaffection and declining affiliation.

Brous's 2016 TED talk, "Reclaiming Religion," has been viewed by more than 1.4 million people and translated into 23 languages. In 2013, she blessed President Obama and Vice President Biden at the Inaugural National Prayer Service, and returned in 2021 to bless President Biden and Vice President Harris. She spoke at the Women's March in Washington, DC in 2017 and at the opening of the National Memorial for Peace and Justice the following year. Brous was named #1 on the Newsweek/The Daily Beast list of the most influential Rabbis in America, and has been recognized by The Forward and the Jerusalem Post as one of the fifty most influential Jews. She was featured on the cover of TIME magazine in 2018 based on Norman Rockwell's Four Freedoms.

Brous is in the inaugural cohort of Auburn Seminary's Senior Fellows program, which unites top faith leaders working on the frontlines for justice. She also sits on the faculty of the Shalom Hartman Institute-North America and REBOOT, and serves on the International Council of the New Israel Fund and the national steering committee for the Poor People's Campaign.

She is a graduate of Columbia University, was ordained by the Jewish Theological Seminary, and lives in Los Angeles with her husband and three children.

She had a choice to go to either Japan or the U.S., and she chose the path to the land of great opportunities, the United States of America. She went to California State University, Los Angeles, where she studied and excelled in Finance.

After graduating from college, Nell immediately entered the work force in California, where she began a career that would later grow into opportunities in small business operations. Having a strong work ethic and ambitious goals, she worked very hard at her places of employment. Her hard work paid off when she gained valuable work experience and business skills that would lead her to become settled in Los Angeles permanently.

#### Theresa Mike

Theresa Mike also known by her traditional Coast Salish name "Si Mi Ihot" (pronounced see-me-laht), is a Lummi Tribal Member. Theresa graduated from Ferndale High School, went on to Whatcom Community College, and earned her Associate of Applied Arts degree in Aquaculture at the Lummi Indian School of Aquaculture in 1977.

Theresa's early years of employment were at Lummi Indian Business Council, Bellingham National Bank, FRK Values Project, and Lummi Casino. Theresa held many different positions while at Lummi Casino, such as a blackjack and poker dealer, cash cage, main bank, hard/soft count, surveillance, and human resources.

Theresa was one of many founding Lummi Tribal members who helped create the Northwest Indian College that is thriving on the Lummi Reservation to date. Theresa remained a Board Member of the Northwest Indian College long after she moved to Palm Springs, California in 1994.

In 1995, Theresa moved to the Coachella Valley to support her husband and the Twenty-Nine Palms Band of Mission Indians in the start-up of Spotlight 29 Casino where she became the Human Resources Director. Theresa then started a GED program that graduated more than 200 employees over a 3-year period. During that time, Theresa attended Chapman University in Palm Desert, California. Theresa went on to become the Community Affairs Director for Spotlight 29 Casino and created Spotlight Cares. Additionally, Theresa created Native Plus Health Consulting during her time employed at Spotlight 29 Casino.

In 1997-1998, with the help of the Twenty-Nine Palms Band of Mission Indians, Theresa was one of the founding members of the Native American Land Conservancy (NALC), whose mission is to protect and preserve. The conservancy holds 2,500 acres in the Old Woman Mountain Preserve and recently acquired a 32-acre parcel in Joshua Tree, California called Coyote Hole.

In 1998, Dean and Theresa established The Theresa A. Mike Scholarship Foundation in memory of their daughter. Theresa is an active board member consistently looking for ways to reach more students through the scholarship program. To date, this foundation has assisted over 800 native and non-native students with financial resources that aided in achieving their academic goals.

In 2018, Theresa was a founding member of the California Indian Nations College (CINC) located in Palm Desert, California. Theresa was inspired to establish the CINC to meet the need for a Tribal College in the State of California that had become evident to Theresa over several decades and help close the disparity in education for tribal members. It was clear to Theresa that California Indian Nations College would help Native American Students feel more comfortable by surrounding them with peers of the same ethnicity. Theresa knew that the creation of the CINC would provide access to education for many tribal students of all ages, regardless if they are enrolling right out of high school, or are adults returning to education. Seeing the initial success of the CINC Theresa is eager for the continued growth of the college.

Theresa's memberships include American Bankers Association, American Legion Auxiliary Post 33 Lummi, Northwest Indian College Foundation, and CINC Foundation.

A committed public servant, Fauzia has been heavily involved in improving the quality of life for her community—from being a PTA mom, to working with the Interfaith Coalition, and numerous volunteer organizations, including City of Corona's Homeless Task Force, Corona Norco Interfaith Association, Beloved Corona, and Cops & Clergy, and more.

During the pandemic, Fauzia co-founded For the People Task Force, a community-based nonprofit. For the People Task Force has provided essential workers with over 20,000 homemade hand sewn masks and has assisted community members with food insecurity and utility debt by hosting over 50 food-drives and raising money to assist in paying their bills. Her efforts have helped thousands of families throughout the Inland Empire.

Fauzia was the first woman elected to the executive board of the Islamic Society of Corona-Norco in 30 years. She currently serves as a Board member and Interfaith Chair for the Board of the Shura Council of Southern California, an organization that consists of 70 non-profits. She has previously served the Chair for the Muslim Complete Count Committee for the 2020 Census. In addition to her roles serving the Muslim community both at a national and regional scale, Fauzia is also ensuring the fiscal stability and security of the Riverside Community College District (RCCD), as a member of the Citizens Bond Oversight Committee.

# **Audrey Casas**

Audrey was raised in Lynwood, California and attended Lynwood public schools. Perfect attendance, exemplary grades and participation in most academic extracurricular activities helped her become Wilson Elementary School's 6<sup>th</sup> grade valedictorian. Unfortunately, she faced many adversities beginning in middle school and High School including gangs, gang violence and drug abuse. However, Audrey is a fierce and determined woman. She kept shining forward with the support and love of her family, husband Saul, her two sons Bruno and Zeus, friends and the community that remains behind her to this day.

After many years of sustained recovery, she completed Cal State Dominguez Hills' Drug and Alcohol Certification Program. She obtained an Associate's degree from El Camino College. She was chosen as 2017's graduating class speaker for the Compton College campus. In June 2019, she graduated from UC Irvine, highlighted as "Top 19 of 2019" Humanities students. She obtained an English degree minoring in Civic and Community Engagement with a specialization in Poverty. She was also chosen to represent UC Irvine at the 2019 Philanthropy Lab in Dallas, Texas. Audrey is currently pursuing a master's degree in Educational Policy and Administration at Loyola Marymount College. This year, Audrey celebrates her 20-year anniversary of employment with Lynwood Unified School District (LUSD) and currently teaches 9<sup>th</sup> grade English at Lynwood High School. In May 2020, she was chosen as employee of the Year by LUSD.

Beginning in April 2020, during the onset of the pandemic, Audrey was able to fundraise over \$80,000 to donate to families experiencing tragedy and economic difficulty during the mandatory lockdown in Los Angeles County. Because of her caring and trusting leadership, she was able to reach out to Lynwood residents, businesses, churches, and elected offices to obtain funds for the community. She organized a team that included her family, fellow educators and hospital administrators, which she called "The Dream Team". Together, they distributed over 800-grocery gift cards first beginning by dropping off cards personally to families' homes, and then organized almost 20 large free food distributions and events throughout Lynwood. In the process, her "Dream Team" became an official organization called "Mastering Hope" that now had distributed over 20,000 care packages. Audrey has frequently stated, "Although we may not be individually wealthy, together we are rich" and "Sustainable change is possible using everyone's spare change, little by little...a little becomes a lot."

Promoting resilience, perseverance and triumph by any means necessary has been Audrey's message and goal for her community that she loves and supports. However, for Audrey this is not work when you enjoy doing it. Above all, she states, "We must have fun getting it done", she explains, "the heaviest times call for hard work and lightheartedness - dark moments must be met with fierce light and positivity". The message that she would like everyone to know is that scars can create stars – what you consider a flaw or impediment could be your biggest asset in making a positive impact."

Joeann Valle was born on January 31, 1939, and grew up in Inglewood. She graduated from Inglewood High and attended El Camino College, near Torrance. She received a bachelor's degree from Cal State Long Beach. When she moved to Harbor City, those who knew her say, she quickly became active in the community. And during her decades in the Harbor Area, Valle became one of the most recognizable figures in the community. Valle, who lived in Harbor City and managed its chamber of commerce was the "go-to" person for government officials, reporters and residents for anything involving the Harbor City and Harbor Gateway areas of Los Angeles. Former L.A. City Councilman Rudy Svorinich Jr. called her an icon and an "irreplaceable force". "She not only placed these two communities on the map in the eyes of all levels of government," he said in a written comment, "she kept them there for over four decades."

Nikki Brown Tennant, who knew Valle for 30 years through their mutual work in public and community service, said, "Valle was the epitome of a community activist in the most positive sense," Tennant said. "She was a fierce advocate for the people and businesses of Harbor City and Harbor Gateway," she added, "before, during and after her time with the chamber of commerce." She was instrumental in the name designation of Harbor Gateway, which had long been referred to simply as the "city strip" because it connected downtown L.A. to the communities of Harbor City, Wilmington and San Pedro to the south.

"Joeann Valle was more than just a dear friend," L.A. County Supervisor Janice Hahn said, "She was a leader and matriarch of the Harbor Gateway Community." Hahn credited her for working with local youth and establishing the Harbor City Cheryl Green Boys & Girls Clubs, where she also served as a board member. Valle also was a founding member of the Harbor City Winter Wonderland Committee that brought in "snow" and winter activities each year during the holidays. Valle was instrumental in helping Hahn bring together the Harbor City Neighborhood Council, who previously served on the L.A. City Council. "She fought hard for quality of life improvements to the city, such as the Harbor City Library and the restoration of the Ken Malloy Harbor Regional Park," Hahn said. "She had such a huge heart for the community and she will be missed." Valle was a Harbor Area planning commissioner, founder of the Harbor City Neighborhood Council, chair of the Harbor Regional Park advisory board, and was on the boards of several other community organizations. She was also the executive director of the L.A. Gateway Chamber, as well as its predecessor, the Harbor City/Harbor Gateway Chamber of Commerce. Valle, who died Jan. 4, after a short battle with lung and bone cancer. She was 81 and is survived by her three children, Gary Bennett Jr. of Oxnard, Julie Bastian of Harbor City and Mark Bennett of Lomita; four grandchildren; and five great-grandchildren (with one more on the way).



For over seven years, Francine has served as district director for Assemblywoman Gonzalez, producing many innovative programs and resources for diverse communities. She spearheaded, for example, multiple safe distributions of essential resources for thousands of constituents during the pandemic. She's also created robust leadership development programs that empower youth, engage and uplift their families through a strong understanding of our legislative system, and helps students from disadvantaged socioeconomic backgrounds succeed in the higher education application process and beyond.

Born in Cavite City, Philippines, Francine was raised in Chula Vista, California. Francine's artistic work has been showcased around the world, in venues including The Kennedy Center, The Lincoln Center, and Seoul Olympic Stadium. She's contributed to multiple Emmy Award-winning TV shows and successful theatrical productions and international concert tours. Her students have won national championships and garnered acceptance into prestigious universities and programs, like that of the Joffrey Ballet. This past year, Francine directed and choreographed the world premiere, award-winning theatrical production of Disney's MOANA.

Francine is a Stage IV lung cancer warrior and survivor. For her work as a vocal advocate to increase awareness and raise funding for advancements in the fight against lung cancer, the #1 cancer killer of women and men worldwide, Francine has been named a Lung Force Hero by the American Lung Association. TEAM FRANCINE, one of the largest teams in the Southern California Lung Force Walk's history, was recognized as a 2020 TOP TEAM.

In 2020, Francine was honored as a "Chula Vista Champion" and one of San Diego Metro Magazine's "Top 40 Under 40."
